Ongoing Investigations	2 (1)	N.J.S.A. 47:1A-3.a. Ongoing investigations “any records pertaining to an investigation in progress by any public agency if disclosure of such record or records shall be detrimental to the public interest. This provision shall not be construed to allow any public agency to prohibit access to a record of that agency that was open for public inspection, examination, or copying before the investigation commenced.
